Humanizing Globalization: Empowering Women

Betty Bayless (Beaufort), AAUW of SC Public Policy Chair and member of the AAUW Public Policy Committee, was a member of the AAUW delegation to the International Federation of University Women, in Perth, Australia, in August. The following story provides a flavor for that conference and the experiences Betty enjoyed with other delegates.

Her Story

G'Day from Perth, Australia, capital of Western Australia and host city for the 28th Triennial Conference of the International Federation of University Women (IFUW), August 4-10, 2004!

Approximately 500 women university graduates from 42 countries gathered to discuss their role in the present economic, social and educational environment; and their availability to the real needs of present society. They took part in the opening ceremony, business and plenary sessions, workshops and interdisciplinary seminars, an Australian evening, and the farewell dinner.

More than 70 AAUW members participated and I served in the nine-member AAUW delegation lead by AAUW President **Nancy Rustad**. My husband Tom and I departed Savannah on August 1 and, after 25 hours in flight, arrived in Perth early in the afternoon of Tuesday, August 3.

Conference registration, the 86th IFUW Council with two representatives from each national federation and association (NFA), and the opening ceremony/reception took place on August 4. The AAUW delegation met that

g to discuss the results of the Council meeting and to prepare for the business session and election of vice presidents that would occur the next day.

Nancy Rustad and AAUW Finance VP Laura Long had explained to Council members that AAUW would not be paying IFUW dues in 2005 and Council members discussed methods to replace that 40% loss in the IFUW budget. According to IFUW Bylaws, NFAs have three years to pay dues before they are removed from IFUW membership.

During IFUW business sessions, delegations are seated at tables in the front of the convention hall similar to UN sessions. Other conference participants attend as observers.

In the first business session on August 5, we acclaimed Griselda Kenyon of Great Britain as IFUW President for 2004-2007 and recognized six new NFAs.

Key issues from the 86th Council meeting were reviewed – the proposed dues increase, the pilot program for individual international members, the budget and need for a task force; and IFUW membership categories. The five candidates for the four vice president positions summarized their goals for IFUW.

We then used a secret ballot with a preferential voting mechanism to elect VPs from New

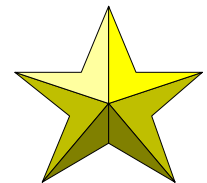

One In A Million Membership Campaign

from AAUW Membership Office

About the Campaign

The *One in a Million Campaign* is a year-long effort (July 1, 2004 through June 30, 2005) to raise \$1 million in unrestricted support for the Association.

AAUW will focus on honorary and paid life members first, asking both groups to participate in the campaign by making a gift of \$120. Each participant will receive the 1881 Fund pin which recognizes the donor's commitment to the mission and programs of AAUW. AAUW will also extend an invitation to all AAUW members and supporters who wish to invest in securing the future of the Association to participate in this exciting campaign.

Nancy Rustad introduced the campaign at the June Leadership Conference, raising more than \$10,000 in a single weekend. The campaign will be supported by a page on the AAUW website which will allow donors to make a secure gift online and follow the progress of AAUW's success each month. Donors will also find a frequently updated list of participating members on the site to follow the success of their branch or state.

Why a Campaign - Now?

The idea for the *One in a Million Campaign* emerged after AAUW President Nancy Rustad was approached by both honorary and paid life members who indicated that they wanted to help the Association address its financial issues. These individuals noted that they had not paid dues in many years but could afford to make a contribution, if asked. After further exploration, AAUW discovered that

approximately 11,000 members held paid or honorary life status. If each of those members made a gift of \$120, AAUW would easily meet its \$1 million fundraising target and so, the *One in a Million Campaign* was born.

What Can I Do? What Can My Branch Do?

The *One in a Million Campaign* is a fundraising effort geared towards individuals. Much like the voter education slogan, *The Power of One Vote*, the campaign relies on the contributions of individuals who are able to personally invest in the future of the Association. While the initial focus will be life members, AAUW invites *all* members to make a \$120 contribution to help reach the goal of the One in a Million Campaign.

AAUW Branches can become a *One in a Million Branch* by achieving 51% participation of their members in the One in a Million Campaign. AAUW will provide a list of donors who have contributed, separated by branch and state, via the AAUW website. Branches may follow the participation of their members and strive for One in a Million Branch status.

Public Policy: National Issues Summary September 2004

AAUW of SC is one of just four state AAUW organizations to be the recipient of an **AAUW Voter Education Grant**. The grant will enable us to:

- prepare and distribute a Voter Guide for the U.S. Senate race;
- conduct candidate and issue forums; coordinate press events; build coalitions; and
- develop Get-Out-The-Vote (GOTV) phone banks.

AAUW Field Director Angela Colaiuta will meet with committee members in Columbia in September to provide technical assistance and guidance in conducting an effective GOTV campaign on a shoestring budget. Look for information on the AAUW of SC web site and in action alerts.

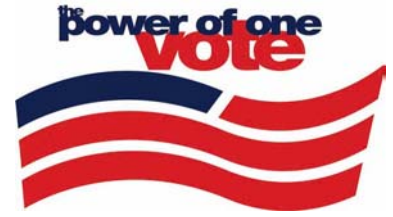
Education First is the former Coalition for Education Equity whose mission is to create a broad-based citizens' groundswell of support to achieve adequate and equitable funding of K-12 public education in South Carolina.

AAUW SC is a member of the steering committee that is planning these activities:

- presentation of town meetings this fall in several locations including **Greenwood** on September 28, **Rock Hill** on October 28 (AAUW branch leading effort), **Florence** on October 11, **Anderson/Clemson** on October 12, **Charleston, Columbia, Beaufort and Greenville/Spartanburg**;
- creation of a statewide media campaign;
- assistance in filing *amicus curiae* briefs in support of the court case in Manning;
- organization of court visitation during the plaintiff's summation;
- creation of a legislative report card containing the voting history on education and related topics by

South Carolina political

- candidates and elected officials; and
- collaboration with the NAACP for the January 17, 2005 Martin Luther King Day March at the State House with an education theme.



Linda Salane, Ph.D., Director of The Leadership Institute at Columbia College, recently shared the draft strategic plan for their partnership with the **SC Commission on Women**.

The Columbia College-Commission on Women Alliance, or the Alliance for short, will consist of five virtual centers: Research; Resource; Talent Bank; Change Councils; and Conference Center. The Alliance will have to raise \$250,000 a year to run it. There will be an Alliance web site.

The first key to success for the Alliance is to define the problems in terms business folks can understand – economic impact. The second key is to link with colleges, government agencies and non-profits in a true Alliance to make women's issues a top priority for South Carolina. We plan to provide input in October.

Tell Them! is a new electronic, advocacy network for South Carolinians who are concerned about the state's rate of teen pregnancy. *We strongly urge you to join*. It's free and is focused on issues we all care about – comprehensive health education and access to care for teens. Visit the web site and sign up at <http://www.tellthemsc.org>.

After many years of serving as a great way to make our advocacy more effective, AAUW's *Get the Facts* service has been retired. In its place, we've developed the **AAUW Action Network**, a more sophisticated e-mail action tool. This network is free to anyone who has an e-mail address, wants to know what's going on in Washington and wants a simple, easy way to take action to affect the outcome.

Association launches new public service announcements

AAUW has introduced new *Because Equity Is Still an Issue* public service advertising – a print ad campaign takes a fresh, clean, and contemporary approach with a focus on the facts that make our message clear – equity for women and girls is still an issue.

Ads can be downloaded from www.aauw.org and are in four-color and black-and-white versions and a variety of popular media sizes.

The ads deliver three distinct messages:

- The average income for a woman with a bachelor's degree is 24% lower than that of a man with the same level of education — \$32,238 vs. \$42,292.

- Even though more women are attending college than ever before, women receive only 19% of bachelor's degrees in physics, 26% in computer science, and 18% in engineering.

- Only 21% of full-time tenured professors are female.

Help AAUW promote equity in education and in the workplace for women and girls in your community. Help us deliver the message – because equity is still an issue.

Why we need to be sure that we and other women exercise their right to vote this year

Take this as a short history lesson on the privilege of voting. Share with your friends, especially those young women in your life who may not realize what other women did to achieve what we have today.

The women were innocent and defenseless. And by the end of the night, they were barely alive. Forty prison guards wielding clubs and their warden's blessing went on a rampage against the 33 women wrongly convicted of "obstructing sidewalk traffic."

They beat Lucy Burn, chained her hands to the cell bars above her head and left her hanging for the night, bleeding and gasping for air. They hurled Dora Lewis into a dark cell, smashed her head against an iron bed and knocked her out cold. Her cellmate, Alice Cosu, thought Lewis was dead and suffered a heart attack. Additional affidavits describe the guards grabbing, dragging, beating, choking, slamming, pinching, twisting and kicking the women.

Thus unfolded the "Night of Terror" on Nov. 15, 1917, when the warden at the Occoquan Workhouse in Virginia ordered his guards to teach a lesson to the suffragists imprisoned there because they dared to picket Woodrow Wilson's White House for the right to vote.

For weeks, the women's only water came from an open pail. Their food--all of it colorless slop--was infested with worms. When one of the leaders, Alice Paul, embarked on a hunger strike, they tied her to a chair, forced a tube down her throat and poured liquid into her until she vomited. She was tortured like this for weeks until word was smuggled out to the press.

So, refresh my memory. Some women won't vote this year because--why, exactly? We have carpool duties? We have to get to work? Our vote doesn't matter? It's raining?

Last week, I went to a sparsely attended screening of HBO's new movie "Iron Jawed Angels." It is a graphic depiction of the battle these women waged so that I could pull

the curtain at the polling booth and have my say. I am ashamed to say I needed the reminder.

All these years later, voter registration is still my passion. But the actual act of voting had become less personal for me, more rote. Frankly, voting often felt more like an obligation than a privilege. Sometimes it was inconvenient.

My friend Wendy, who is my age and studied women's history, saw the HBO movie, too. When she stopped by my desk to talk about it, she looked angry. She was--with herself. "One thought kept coming back to me as I watched that movie," she said. "What would those women think of the way I use--or don't use--my right to vote? All of us take it for granted now, not just younger women, but those of us who did seek to learn." The right to vote, she said, had become valuable to her "all over again."

HBO will run the movie periodically before releasing it on video and DVD. I wish all history, social studies and government teachers would include the movie in their curriculum. I want it shown on Bunko night, too, and anywhere else women gather. I realize this isn't our usual idea of socializing, but we are not voting in the numbers that we should be, and I think a little shock therapy is in order.

It is jarring to watch Woodrow Wilson and his cronies try to persuade a psychiatrist to declare Alice Paul insane so that she could be permanently institutionalized. And it is inspiring to watch the doctor refuse.

Alice Paul was strong, he said, and brave. That didn't make her crazy. The doctor admonished the men: "Courage in women is often mistaken for insanity."

Please pass this on to all the women you know. We need to get out and vote and use this right that was fought so hard for by these very courageous women.

Difficult times result in difficult decisions

AAUW's long tradition of activism in the pursuit of equity for all women and girls comes with a price tag. – a price tag that costs hours of time and talent by volunteer leaders, members and staff alike.

These are difficult times for all organizations, whether non-profit or for-profit, and AAUW is no exception. Declining membership, coupled with decline in investment income, has resulted in your Association leadership team taking a



close look at how our business is run and how we can make our financial outlook a promising one for our future.

Since the beginning of this year, your Association Board leaders had some very hard decisions to make relative to AAUW's program of work, ways of doing business, and plans for the organization's future. These decisions were made only after long discussion and careful consideration of the consequences of such decisions. Please know that your Association leaders, both volunteers and staff, are committed to ensuring AAUW's future, so that AAUW will reflect its mission in all that it does for many years to come.

Working together, volunteer leaders and staff have made many across-the-board cuts in the Association budget. Several staff positions were terminated, a hiring freeze was instituted for six months, extras of any kind were cut from budgets, and other measures such as cutting travel budgets were put in

place. Six Regional Directors funded their own travel expenses to the state leadership conference in Washington in June, and all Board members committed to funding half of their travel expenses for the current membership year.

One of the more controversial actions by the Board has been the decision to not pay 2005 dues to the International Federation of University Women (IFUW), of which AAUW is a founding federation and of which every AAUW member is automatically a member by payment of AAUW dues. When facing IFUW dues of probably more than \$300,000 and an Association proposed budget deficit of almost \$400,000, the Board could not in good conscience continue to borrow from reserves to pay these dues. This decision in no way reflects AAUW's lack of interest in international issues, and there are indeed many others ways that AAUW is working on a global scale for women's issues.

Association Board members are working in teams to explore ways to better structure the Association board and staff, to examine all programming and services for viability and purpose, and to find ways to increase non-dues revenue in an organization that is 85% membership dues based.

One new effort in raising non-dues revenue is the new *One in a Million Campaign* that is described elsewhere in this newsletter.

These are indeed difficult times with difficult decisions. Your Association leaders are dedicated and committed to ensuring AAUW's future and ensuring that the organization of the future supports its members and branches in everyway possible.

Hold a Membership Dialogue and shape the future of AAUW

For several years AAUW members have debated the organization's membership requirements that open AAUW membership only to people with four-year degrees. In 2003, delegates to the AAUW National Convention passed a resolution charging the Association to conduct a structured Association-wide dialogue on the suitability of the current membership requirements and categories. The resolution calls for a discussion, nothing more. The AAUW Membership Committee will review the responses and delegates will take up the issue again at the 2005 convention.

The dialogues are to take place in two forms. State and branch leaders will conduct open dialogue sessions with their local members, returning feedback as a state or branch. Individual members — including members-at-large, student affiliates, and college/university partners — are asked to contribute their perspectives on this issue through an individual dialogue survey form. State/branch members who participate in a group discussion, but would also like to

contribute as an individual member, are welcome to complete the individual survey as well.

The membership dialogue materials are now available through pages on the AAUW website. You can access at:

http://www.aauw.org/member_center/dialogues.cfm or through the AAUW website (www.aauw.org) in the Member Center - via the Member Center front page, the Leaders' Corner page or the Branches and States page.

On behalf of the entire AAUW Membership Committee, I urge you to give the dialogues your most serious attention. The survey results should reflect the opinions of **all** members. In turn, **members** – not staff – will drive the entire process, including compilation and analyzing of survey results.

We also urge your help in meeting the deadline of November 15. Thanks for your help and input. This process is important to the future of our organization.

Zealand, the USA, Turkey and Canada. Our delegation had 17 votes out of the total voting strength of 127.

After lunch our delegation met with all AAUW members to share the basis for AAUW's difficult decision that resulted in non-payment of IFUW dues for 2005. The afternoon concluded with plenary sessions about the history and activities of IFUW. Our delegation met that evening to prepare for election of IFUW committee conveners and resolution introductions.

The business session on August 6th began with the acclamation of Terry Oudraad of the Netherlands as IFUW Treasurer. The Irish, Korean and Mexican Federations described the programs they used to increase membership. IFUW honored four NFAs for these projects: Vanuatu – domestic violence and human rights; Nigeria – national workshop on conflict resolution; Samoa – dictionary project encouraging girls to become women graduates; and Canada – forum to raise awareness of the impact of government policies on women and children. We learned about Bina Roy Projects and received copies of a new booklet: IFUW in Action 2001-2004.

Before the afternoon session, our delegation met again with AAUW members to discuss resolutions and the dues situation. The plenary session provided a discussion of IFUW activities at the United Nations New York, Paris and Geneva. We heard about the plans for forums in Geneva in December 2004, the Beijing + 10 conference in March 2005 in New York, and the UN Millennium Development Goals. The session closed with the introduction of 12 public policy resolutions and two emergency resolutions.

Eight Interdisciplinary Seminars focused on the conference theme on Saturday, August 7th. These sessions provided the opportunity for graduate women, both members and non-members of IFUW, to share their research and to describe their work. I

attended the full-day program on "Humanizing Globalization: Political-economic Perspectives" that was facilitated by the president of the Cameroon Association and featured speakers from Nepal, India, Australia, the USA, Canada, Argentina, Nigeria and Sri Lanka.. The day concluded with the Australian Evening at the Art Gallery of Western Australia – an opportunity to taste the food and wines of Australia, view indigenous Australian art, and enjoy performances by aboriginal entertainers.

Sunday, August 8th was Workshops Day at the University of Western Australia – 26 workshops were offered. I attended the morning session on the work of IFUW at the United Nations and an afternoon program on how IFUW is involved in the United Nations Girls' Education Initiative. At the end of the day I facilitated a discussion of the resolution that AAUW proposed to IFUW – Women in Decision-Making Positions in World Financial Institutions.

Monday's first business session focused on the discussion and approval of amendments to IFUW's Constitution and Bylaws. Delegates rejected proposals for dues increases of two and four Swiss francs, and approved a six Swiss franc increase for total individual dues of 18 Swiss francs. AAUW abstained from these votes.

The second business session dealt with the amendment and adoption of ten IFUW public policy resolutions. I presented AAUW's resolution that was seconded by Canada and supported by Japan, Mexico and the UN delegation. The resolution passed unanimously.

We also accepted two emergency public policy resolutions. Most of the resolutions addressed the needs of women and children with a focus on education, rights, diversity and peace. We completed the session by adopting resolutions that addressed: the role of young members in IFUW; NFA emerging issue think tanks; the

responsibility for the 30th conference; the pilot program for individual international membership; and the review of IFUW categories of membership.

On Tuesday, the conference began with a keynote speech on "Communicating in a Global Organization" and the role women play in language diversity. IFUW then launched its new program theme, "Women: Agents for Change".

The final business session included: introduction of the Next Generation Group that will assist in future efforts of IFUW; the invitation from the British Federation to the 29th Conference in 2007 in Manchester, England; the recognition of retiring officers; and the introduction of the new board and committee conveners.

That evening participants and guests gathered for the special farewell dinner and entertainment...an opportunity to confirm new friendships and reinforce those from past conferences.

It was an honor and pleasure to represent AAUW at this historic meeting! Australia and its citizens are wonderful!

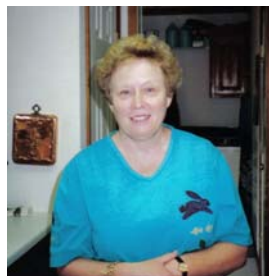
